



Gators & Gold Fishing Charters Liability Waiver & Assumption of Risk Agreement

Note: This agreement shall be governed by the laws of Alberta, and any legal action must be brought in that jurisdiction.

1. Acknowledgment of Risk. I understand that participating in a guided fishing charter involves inherent risks, including but not limited to:

- Slips, trips, and falls on wet or uneven surfaces;
- Injuries from fishing equipment (hooks, rods, lures, knives);
- Water-related risks including drowning;
- Changing weather and water conditions; and
- Travel by boat and boarding/disembarking.

*I voluntarily accept and assume all risks associated with participation.

2. Release of Liability. In consideration of being allowed to participate in this fishing charter, I hereby release, waive, and discharge Gators & Gold Fishing Charters, its owner(s), employees, and agents from any and all liability for injury, loss, or damage, including death, arising from participation; except where caused by gross negligence or willful misconduct.

3. Participant Responsibility. I agree to:

- Follow all safety instructions provided by the guide;
- Wear a life jacket when required;
- Use all equipment responsibly; and
- Be responsible for any damage or injury I cause to others or to property during the charter.

*I acknowledge that failure to follow instructions may increase risk.

4. Medical Fitness. I confirm that I am physically able to participate in this fishing charter. I understand that it is my responsibility to disclose any conditions that could impact my safety.

5. Alcohol & Substance Policy. I understand that unsafe behavior due to alcohol or drugs will not be tolerated and may result in termination of the charter without refund.

6. Weather & Cancellation. I understand that chartered trips may be modified or cancelled due to weather or safety concerns at the guide's discretion.

7. Photography & Media Consent (Optional). I grant permission for photos/videos taken during the charter to be used for promotional purposes. I DO NOT grant permission (check box)

8. Minors. For participants under 18, a parent or legal guardian must sign this agreement which indicates acceptance of full responsibility for the minor or minors during the charter.

9. Agreement & Understanding. I have read and fully understand this agreement. I accept that the charter is provided as is and there is no guarantee of conditions or catch success. I also acknowledge that I am giving up certain legal rights, including the right to sue.
